If your car was registered before that date you will need to provide proof that it is Euro 6 compliant. If you are unable to do this, you will need to pay the diesel surcharge. All van owners will need to prove their vehicles are Euro 6 compliant to avoid paying the diesel surcharge.

We also charge a supplementary fee if there is more than one car permit in your household.
