## What is Community Infrastructure Levy and Neighbourhood Community Infrastructure Levy?

- Community Infrastructure Levy (CIL) is a charge that the Council collects from new development in the borough. It is an important tool introduced by the Government to help Councils deliver the infrastructure needed to support development.
- CIL regulations require that a proportion of CIL (15%) is set aside as Neighbourhood CIL (NCIL) to be spent on local priorities identified by local communities. Where a <u>neighbourhood plan</u> exists, the proportion of NCIL is higher (25%) and is to be spent on infrastructure identified in the relevant neighbourhood plan. The borough has two neighbourhood plans <u>St Quintin and Woodlands</u> and <u>Norland</u>.
- As of April 2020, the Council has £2.9 million of NCIL funds, to be spent on local priorities.

# What can the Neighbourhood Community Infrastructure Levy be used for?

The CIL Regulations set out what NCIL can be used for:

(a) the provision, improvement, replacement, operation or maintenance of infrastructure; or

(b) anything else that is concerned with addressing the demands that development places on an area.

### **Community priorities**

The Council consulted on NCIL community priorities between February and March 2020. Over 250 votes and 375 responses were received in total. These have been used to establish the community priorities below, these will guide allocating NCIL funds:

- Air Quality
- Policing resources and Emergency Services
- Parks and Open Spaces
- Streetscape
- Community Safety

The consultation also identified community priorities by ward.

## How much cash is available?

As of April 2020, the Council has £2.9 million of NCIL funds. A 25 per-cent 'top-slice' of this is distributed equitably, so that every ward has NCIL funds. The rest of the sum will be retained by wards where development took place and, therefore, will have generated the money. A top slice is not taken from neighbourhood plan areas. The sums available are set out in the diagram below and further details are set out in the NCIL document.

#### How to access NCIL funds

Residents, local community groups, residents' associations, registered charities, infrastructure providers and charitable companies can bid for NCIL funding by submitting a completed application form to the Council. The application form and accompanying guidance note is available on the Council's website – <u>https://planningconsult.rbkc.gov.uk/consult.ti</u>.

All funding applications will be checked and then provided to Ward Members for decision

There are a number of criteria that projects should aim to meet. These are summarised below:

- The project relates to one or more of the identified community priorities for the ward or Neighbourhood plan priorities
- The project meets CIL regulations
- The project benefits the local and wider community in the borough
- The project does not require additional revenue funding in its delivery or its operation (or identifies how additional revenue funding may be met)
- The project is deliverable
- Offers value for money

The application period will be open twice a year.
