## Statement of Consultation Procedure

Notice is hereby given, in accordance with regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2012 that the Royal Borough of Kensington and Chelsea have produced the proposed submission version of two planning policies for a partial review of the Core Strategy for the Royal Borough of Kensington and Chelsea with a focus on North Kensington.

(a) Title of Document

Planning Policy for public houses and other uses which provide a wider social role and a planning policy relating to use and character

(b) Subject matter

A policy which will be inserted into the adopted Core Strategy, deals with the protection of public houses in the Borough and those uses which provide a wider social role. Another policy will be inserted into the adopted Core Strategy which relates to use and character.
