In commenting on the whole policy, I welcome all of the proposals contained within the Basements Publication Planning Policy dated July 2013.


I welcome the sensible, well-considered view being put forward by the Council. Too many basement developments adversely impact the quality of life of all those who live and work around them, and many of the causes of these impacts could be prevented or better contained if dealt with at the Planning stage.

I write as an owner/resident who has lived through two close, large, year long+ basement developments that shook my property (a shop and basement, plus above a maisonette on three floors which is my home), and caused minor fine cracking to appear in the paintwork of walls and cornices on all floors. I was not the neighbour directly affected for party wall award – rather my property was one property over. The vibrations caused by the piling and drilling work that went on for several months made it a nightmarish existence, and at times, impossible to work. The dust thrown up into the air by the excavations was palpable. I had headaches, couldn't sleep, and, trying to relax through yoga I'd lie on the yoga mat on my top floor and feel drumming vibrations that coursed through my body – relaxing was not possible.

Furthermore as a neighbour I had objected to the proposed basement works on one of the sites only because of the proposed loss of a mature and graceful tree that had straddled the border between the property and the public sidewalk. The tree in its height and girth had visually obscured and softened the visual impact of the back of the corner property. A small tree was to be planted on the roof of the new ground floor that was built over the new basement to replace the mature tree. It was planted in a pot and it died within two years. The street scene lost yet another tree to a basement development.

I believe that this proposal in all its parts is sound and sensible; and it will go some good way to prevent and contain the increasing number of basement development excesses and abuses that have been challenging residents in the Royal Borough these past some years.
