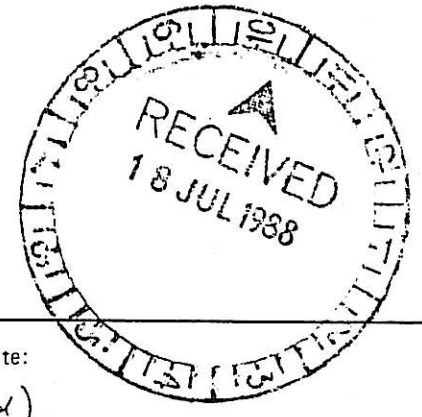

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDERS 1977 TO 1987ARTICLE 4 (1) DIRECTION

WHEREAS the Council of The Royal Borough of Kensington and Chelsea being the appropriate local planning authority for the said Borough within the meaning of Article 4 of the Town and Country Planning General Development Order 1977 (as amended) are satisfied that it is expedient that development of the description set out in Schedule 1 hereto should not be carried out on the land described in Schedule 2 hereto and shown hatched red on the plan annexed hereto unless permission therefore is granted on application made under the Town and Country Planning General Development Orders 1977 to 1987.

NOW THEREFORE the said Council in pursuance of the Powers conferred upon them by Article 4 of the Town and Country Planning <sup>G</sup> general Development Orders 1977 to 1987 hereby direct that the permission granted by Article 3 of the said order shall not apply to the said development intended to be carried out on the said land.

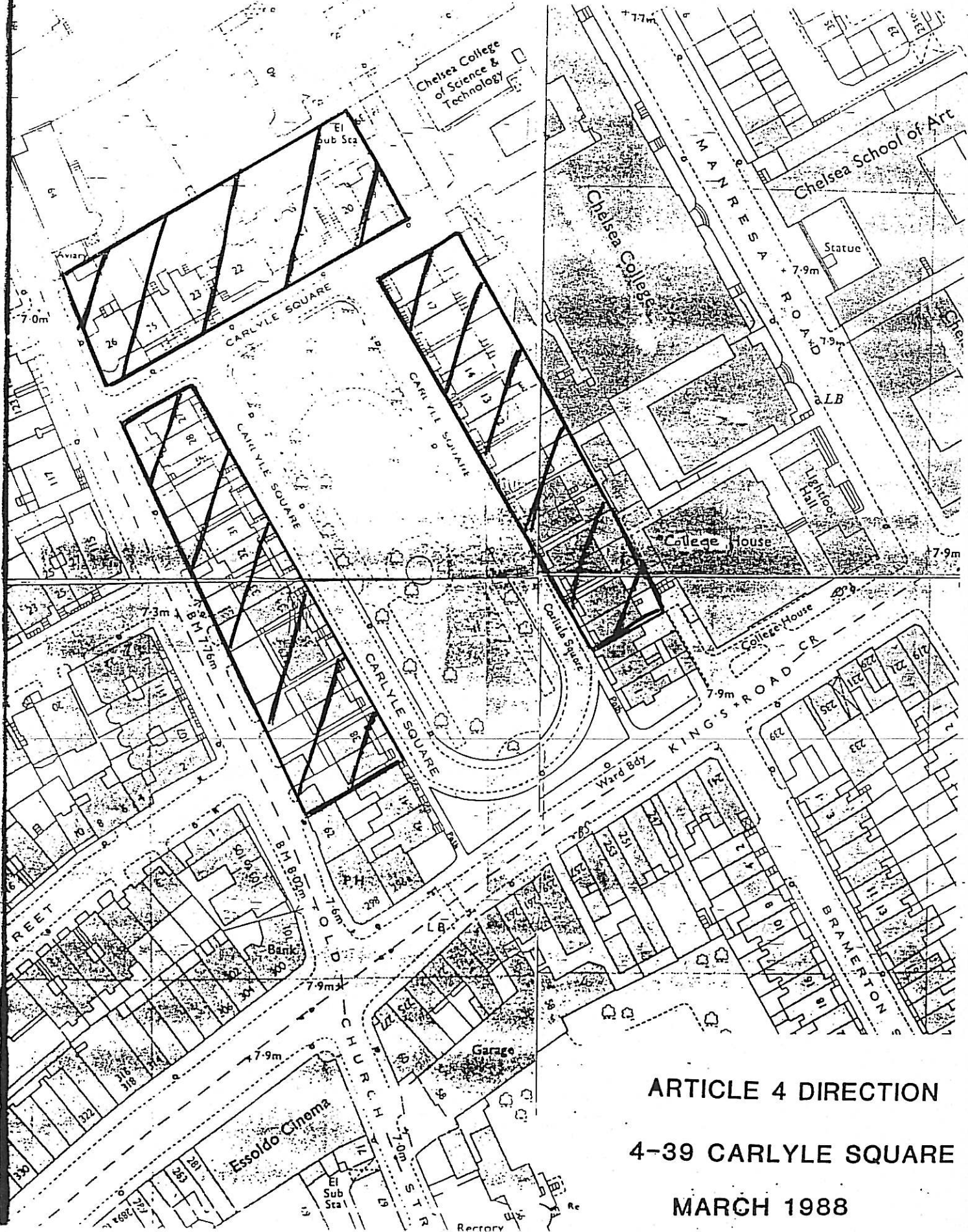
