#### **Statement of Consultation Procedure**

Notice is hereby given, in accordance with regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2012 that the Royal Borough of Kensington and Chelsea have produced the publication version of planning policies for a partial review of the Core Strategy for the Royal Borough of Kensington and Chelsea with a focus on North Kensington.

### (b) Subject matter

- i) Basements Publication Planning Policy, July 2013
  A policy which will be inserted into the adopted Core Strategy, is a new bespoke policy to ensure that all basements are designed, constructed and completed to the highest standard and quality.
- ii) Housing Publication Planning Policies, July 2013
  Policies which relate to the nature of housing within the Borough.
  It includes policies on housing diversity which includes housing mix and type as well as clauses relating to affordable housing.
  The review does not include former policy CH4, Estate Renewal.
  This policy is unchanged.
- iii) Miscellaneous Matters Publication Planning Policies, July 2013
  The 'Miscellaneous Matters' policy review includes a general updating exercise of the Core Strategy to ensure that the text reflects the latest Government guidance and other evidence based documents. It also deals with other Unitary Development Plan policies being incorporated into the Core Strategy, such as servicing, temporary sleeping accommodation and embassy location within the Borough. The relevant Core Strategy replacement to the current EcoHomes Very Good standard in terms of BREEAM for refurbishment is also dealt with.
- vi) Conservation and Design Publication Planning Policies, July 2013
  The 'Conservation and Design' policy review includes a
  general updating exercise of the policies to ensure that the
  text reflects the latest Government guidance and other

evidence based documents. It also deals with other Unitary Development Plan policies, with a focus on conservation and design, being incorporated into the Core Strategy.
